RESOLUTION FOR ALLOCATION OF AMERICAN RESCUE PLAN ACT FUNDS TO CARRY OUT AN ECONOMIC DEVELOPMENT PROJECT

WHEREAS, Coosa County, Alabama ("the County") has received American Rescue Plan Act state and local fiscal recovery funds ("ARPA funds") and is charged with ensuring that such funds are expended in accordance with state and federal law; and

WHEREAS, in accordance with the provisions of final rule published by the United States
Department of Treasury dated January 6, 2022, the County has duly elected to designate a standard allowance of up to \$10,000,000 of its ARPA funds, not to exceed the County's total ARPA funds award, as revenue replacement ("revenue replacement funds"); and

WHEREAS, these public funds may be used for the purpose of providing government services, including investments to foster economic development; and

WHEREAS, consistent with Alabama Const. § 94.01, the County may provide funds to a local nonprofit entity for the purposes of encouraging economic development, notwithstanding any incidental benefit accruing to the entity; and

WHEREAS, the Coosa County Chamber of Commerce (the "Chamber") has submitted a request for funding to develop a new website to promote economic development and provide information for the general public, as well as for the development and associated advertisement costs of marketing and promotional materials for the community ("Project"); and

WHEREAS, consistent with Alabama Const. § 94.01, the County issued a public notice regarding the allocation of fund for economic development on November 1, 2024; and

WHEREAS, after consideration of the proposed Project, the County has made a determination that this is a reasonable, appropriate, and lawful expenditure as the project serves a public purpose benefiting a significant portion of the community.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- The Commission hereby allocates ARPA funds designated as revenue replacement funds to cover up to \$15,000.00 in funds towards development and support of a new website and marketing and promotional materials for the Chamber.
- The Commission resolves to enter into a funding agreement with the Chamber in a form substantially similar as the agreement provided as Attachment 1 hereto.
- 3) Upon execution of the agreement, the County Administrator is hereby authorized to expend ARPA funds revenue replacement funds for costs of the Project in accordance with the terms of this Resolution and the funding agreement.

- 4) The County ARPA Program Director is responsible for ensuring that, in carrying out the obligations under the agreement, the Project meets the requirements of the County's ARPA award, that no funds will be expended on ineligible costs as defined by Treasury's Final Rule, and that the Project will not frustrate the County's ability to mitigate or prevent against the spread of COVID-19.
- 5) Expenditure of these funds, as authorized by this Resolution, shall be contingent on the continued appropriation and availability of ARPA funds for this purpose and in no event shall be used for any costs associated with the project that are not obligated on or before December 31, 2024, and expended on or before December 31, 2026.

THIS AGREEMENT (herein called the "Agreement") entered into upon the date signed by both parties below, is by and between Coosa County, Alabama (herein called the "County") and the Goodwater Volunteer Fire Department (herein called the "VFD"); and

WHEREAS, the County has received a Coronavirus State and Local Fiscal Recovery Fund ("SLFRF") award under the American Rescue Plan Act ("ARPA funds") from the U.S. Department of the Treasury ("Treasury"), which, in accordance with the Final Rule issued by Treasury on January 6, 2022, have been duly designated as revenue replacement funds ("revenue replacement funds"); and

WHEREAS, these public funds may be used for the purpose of providing government services, including support of emergency services, community engagement, and fostering of fair elections in the County; and

WHEREAS, the County may donate public money or other things of value to volunteer fire departments because these organizations benefit the general public, are not engaged in private enterprise, and therefore have a lawful public purpose, *Slawson v. Alabama Forestry Comm'n*, 631 So.2d 953 (Ala. 1994); and

WHEREAS, the County recognizes that the County's volunteer fire departments play a substantial and important role in providing these needed emergency response and assistance services to the residents throughout the County; and

WHEREAS, the Goodwater Volunteer Fire Department is in need of a new facility in the Goodwater region area to better provide more immediate services to the citizenry; and

WHEREAS, the Goodwater area is also in need for an additional polling location in the Goodwater area to facilitate fair and equitable elections; and

WHEREAS, the Commission has determined that the support of these local volunteer fire departments is a necessary, eligible, and reasonable use of these funds and fulfills a public purpose for a significant portion of the community.

NOW, THEREFORE, it is agreed between the parties hereto that:

RESOLUTION FOR THE EXPENDITURE OF AMERICAN RESCUE PLAN ACT FUNDS FOR GOVERNMENT SERVICES

WHEREAS, Coosa County, Alabama (the "County") has received American Rescue Plan Act fiscal recovery funds ("ARPA funds") and is charged with ensuring that such funds are expended in accordance with state and federal law; and

WHEREAS, in accordance with the provisions of final rule published by the United States Department of Treasury dated January 6, 2022, the County has duly elected to designate a standard allowance of up to \$10,000,000 of its ARPA funds, not to exceed the County's total ARPA funds award, as revenue replacement ("revenue replacement funds"); and

WHEREAS, the County may use revenue replacement funds to fund government services, like the provision of safe roads in the County; and

WHEREAS, the County has determined that the procurement of the following equipment from the following vendors is a necessary, reasonable, and proportionate measure to facilitate the provision of these government services:

A backhoe for \$127,980.64 from Warrior Tractor & Equipment Company, Inc.; and

WHEREAS, the County has identified the vendor from which to procure these vehicles in a manner consistent with state laws and federal guidelines, as required by the terms and conditions of the ARPA as it relates to the expenditure of revenue replacement funds.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1) The County shall use up to \$22,059.02 of ARPA funds, which are hereby designated as revenue replacement funds, to facilitate the provision of the government services described herein. The remaining balance shall be paid using other legally available funds for the County.
- 2) The Coosa County Administrator is hereby authorized to expend these funds to facilitate the provision of these services.
- 3) The ARPA Program Director is charged with ensuring that revenue replacement funds allocated and expended to provide these government services will not be used in such a way as to frustrate COVID-19 mitigation guidance issued by the Centers for Disease Control, or for any other use prohibited by the Final Rule or any applicable state or federal law.
- 4) Expenditure of these funds, as authorized by this Resolution, shall be contingent on the continued appropriation and availability of ARPA Revenue Replacement funds for this purpose and in no event shall be used for any expenses not obligated by December 31, 2024, and expended by December 31, 2026.

LaBella Associates, D.P.C. (LaBella) appreciates the opportunity to offer professional consulting services to the Coosa County Commission for development of the Solid Waste Management Plan (SWMP) for Coosa County ("the County"). LaBella is submitting this proposal for your review and consideration, which includes a description of the consulting services to be performed (Scope of Services), fees, and terms and conditions.

PROJECT UNDERSTANDING

The following proposal is in accordance with previous conversations between representatives of the County and members of LaBella's Waste & Recycling Division. Based on our understanding of those conversations, LaBella will prepare a draft Solid Waste Management Plan, in accordance with the applicable requirements of §22-27-47, Code of Alabama. The scope of this effort is described more fully below.

SCOPE OF SERVICES

The following scope of services and fees are intended to address the services which LaBella believes will be required to prepare a SWMP in accordance with the requirements of State law, and see that Plan through adoption and approval. Specific required services are identified as follows:

TASK 01 -SOLID WASTE MANAGEMENT PLAN DEVELOPMENT

Alabama state law requires each county to development a plan for the management of solid waste within its boundaries. This Plan must be developed in accordance with the requirements of §22-27-47, <u>Code of Alabama</u> and must address the management and disposal of solid wastes for a period of no less than ten years. Prior to final adoption of the Plan by the local governing body, the Plan shall be subject to a public comment period of no less than 30 days and the subject of at least one public hearing. The governing body must then adopt the Plan within 60 days of the hearing in a meeting open to the public.

Lastly, following adoption of the Plan by the governing body, the Plan must be submitted to the Alabama Department of Environmental Management (ADEM) for formal review and approval.

To accomplish the above on behalf of the County, LaBella proposes to do the following:

Prepare a draft Solid Waste Management Plan for Coosa County, per the requirements of §22-27-47(b), Code of Alabama,

Provide a copy of the draft Plan to the County for review and comment.

Provide a copy of the draft Plan to ADEM for informal feedback prior to the public notice phase of the Plan approval,

Revise and amend the draft Plan as needed due to feedback from the County and/or ADEM,

- Present the final draft Plan on behalf of the County during the required public hearing, including responding to any public comments or questions concerning the draft Plan, as directed by the County,
- Submit the final adopted Plan to ADEM for formal approval.

DELIVERABLES

The deliverable for the scope of services is as follows:

> Task 01 - Development of draft Solid Waste Management Plan; presentation at the public hearing; response to comments, and general consulting regarding implementation of the Plan.

SCHEDULE

The schedule for the scope of services is as follows:

Task 01- The County's SWMP expired in 2014. Given the timing of the legally required process for adoption of a new SWMP, we expect a new Plan will be submitted to ADEM for approval within 6 months of approval of this proposal.

ASSUMPTIONS AND LIMITATIONS

This scope of services and budget are based on the following assumptions and limitations:

Client-generated activities beyond this scope of services and in excess of the budget are subject to additional charges billed at hourly rates plus expenses or negotiated fees and may affect the task schedule accordingly.
