Mrs. Lewis has been a licensing clerk for almost three years. Without doubt, Mrs. Lewis not only met but far exceeded all the requirements outlined her initial hire letter. Mrs. Lewis always performs her duties in an outstanding and professional manner. She always treats each customer with the utmost respect regardless of the situation, some which are very unpleasant. In addition, she quickly learned the newly implemented vehicle licensing system and attended many training sessions to become proficient. She became the licensing office go to person for questions and/or unique situations. She willingly handles the more difficult tasks, given the option other licensing clerks avoid.

2. She quickly learned the broad and intricate aspects of the licensing office and keeps up with the constant state and federal changes relating to motor vehicles, boats, Department of Natural Resources, and other licensing functions. Not only did she learn her primary duties as a motor-vehicle licensing clerk but also very willingly cross-trained to learn and

conduct some operations in the social ig and Driver Licensing office.

She is an invaluable asset to my office and this county. This is especially true considering all the changes affecting our offices, especially elections. There are occasions when Mrs. Weathers, Mrs. Stroud, and I are all mandated to attend classes to learn new software, election processing, or other items related to the probate office. Without Mrs. Lewis' willingness to learn aspects of both offices, our only options would have been to either close the driver licensing and recording office or miss mandated training that would prevent one of us from accessing and working to update data in the state's election systems and working the critical aspects of conducting an election. She voluntarily assists as needed to work election preparation and election nights. She attends departments of Motor Vehicle and Revenue training classes when offered. She also attended state-sponsored training sessions aiding our implementation of the new ALEA LEADS (driver licensing) program.

For these reasons, I request the Coosa County Commission approve a two (\$2.00) dollar per hour increase for Mrs. Lewis effective immediately. The funds are in my budget, and I have discussed this with Administrator Gilliland. We have invested a lot to train Mrs.

Lewis and, in my opinion, Coosa County cannot afford to lose her.

# RESOLUTION FOR THE EXPENDITURE OF AMERICAN RESCUE PLAN ACT FUNDS FOR GOVERNMENT SERVICES

WHEREAS, Coosa County, Alabama (the "County") has received American Rescue Plan Act fiscal recovery funds ("ARPA funds") and is charged with ensuring that such funds are expended in accordance with state and federal law; and

WHEREAS, in accordance with the provisions of final rule published by the United States Department of Treasury dated January 6, 2022, the County has duly elected to designate a standard allowance of up to \$10,000,000 of its ARPA funds, not to exceed the County's total ARPA funds award, as revenue replacement ("revenue replacement funds"); and

WHEREAS, the County may use revenue replacement funds to fund government services; and

WHEREAS, the County has determined that there is a need to replace two law enforcement vehicles; and

WHEREAS, the County has determined that the procurement of the following vehicles from the following vendor is a necessary, reasonable, and proportionate measure to facilitate the provision of these government services:

Two 2023 Ford F150 Responder Supercrew 4x4 Pickups from Stivers Ford Lincoln for a total of \$83,000; and

**WHEREAS**, the County has identified the vendor from which to procure these vehicles in a manner consistent with state laws and federal guidelines, as required by the terms and conditions of the ARPA as it relates to the expenditure of revenue replacement funds.

### NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1) The County shall use up to \$83,000 of ARPA funds, which are hereby designated as revenue replacement funds, to facilitate the provision of the government services described herein.
- 2) The Coosa County Commission hereby authorized to expend these funds to facilitate the provision of these services.
- 3) The ARPA Program Director is charged with ensuring that revenue replacement funds allocated and expended to provide these government services will not be used in such a way as to frustrate COVID-19 mitigation guidance issued by the Centers for Disease Control, or for any other use prohibited by the Final Rule or any applicable state or federal law.
- 4) Expenditure of these funds, as authorized by this Resolution, shall be contingent on the continued appropriation and availability of ARPA Revenue Replacement funds for this purpose and in no event shall be used for any expenses not obligated by December 31, 2024, and expended by December 31, 2026.

WHEREAS, the County may expend LATCF Funds for programs, services, and capital expenditures to fulfill a governmental purpose; and

WHEREAS, the purchase of financial software for the County serves a governmental purpose ensure proper resource management; and

WHEREAS, the County has identified a software product and will procure the software consistent with state law and federal procurement standards applicable to LATCF Funds.

## NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1) The County shall use up to \$55,959.33 of LATCF Funds to purchase financial software from SHI International, Inc., to fulfill the governmental purpose described herein.
- 2) The County Administrator is hereby authorized to expend these funds to purchase services to fulfill this government service.
