#### **CALL TO ORDER**

THE COOSA COUNTY COMMISSION MET AT THE COOSA COUNTY COURTHOUSE JANUARY 24, 2024 @ 4:30 P.M. FROM A RECESSED MEETING ON JANUARY 9, 2024 WITH CHAIRMAN BERTHA K. MCELRATH PRESIDING.

## INVOCATION AND PLEDGE OF ALLEGIANCE

INVOCATION WAS GIVEN BY COMMISSIONER BRANDON DAVIS. THE PLEDGE OF ALLEGIANCE WAS SAID BY ALL IN ATTENDANCE.

### **EMPLOYEE DISCIPLINARY HEARING**

MOTIONED BY COMMISSIONER JOHN FORBUS TO GO INTO EXECUTIVE SESSION AND TO ALLOW THE SHERIFF TO REMAIN PRESENT AS SECURITY DURING THE EMS EMPLOYEE DISCIPLINARY HEARING MEETING FOR DARRELL BRANDON JACKSON. SECONDED BY COMMISSIONER RONNIE JOINER. UNANIMOUSLY APPROVED

HOLLIE OSBOURN, EMS DIRECTOR WAS CALLED AS THE FIRST WITNESS AND SWORN IN BY ADMINISTRATOR AMY GILLILAND.

EMS EMPLOYEE BRANDON JACKSON WAS CALLED INTO THE MEETING AND SWORN IN BY ADMINISTRATOR AMY GILLILAND. MR. JACKSON WAS MADE AWARE OF THE PURPOSE OF THE EMPLOYEE HEARING MEETING AND WAS TOLD BY ATTORNEY JOHN KELLEY JOHNSON THAT THE COMMISSION WOULD MAKE A DECISION BEFORE THIS MEETING ADJOURNED. UPON HEARING ALL TESTIMONIES, THE COMMISSION DECIDED TO REVERT MR. JACKSON'S EMPLOYMENT FROM FULL-TIME STATUS TO A 90 DAY PROBATIONARY PERIOD THAT WILL BEGIN ON JANUARY 28, 2024.

MOTIONED BY COMMISSIONER RONNIE JOINER TO GO INTO EXECUTIVE SESSION AND TO ALLOW THE SHERIFF TO REMAIN PRESENT AS SECURITY: DURING THE EMS EMPLOYEE DISCIPLINARY HEARING MEETING FOR JEFFERY PAINTER. SECONDED BY COMMISSIONER JOHN FORBUS. UNANIMOUSLY APPROVED

HOLLIE OSBOURN, EMS DIRECTOR WAS CALLED AS THE FIRST WITNESS AND SWORN IN BY ADMINISTRATOR AMY GILLILAND.

EMS EMPLOYEE JEFFERY PAINTER WAS CALLED INTO THE MEETING AND SWORN IN BY ADMINISTRATOR AMY GILLILAND. MR.
