RESOLUTION PROVIDING FOR COOSA COUNTY'S PARTICIPATION IN THE "SEVERE WEATHER PREPAREDNESS SALES TAX HOLIDAY" AS AUTHORIZED BY ACT NO. 2012-256

WHEREAS, during its 2012 Regular Session, the Alabama Legislature enacted Act No. 2012-256, effective April 26, 2012, which provides an exemption of the state and use tax for certain severe weather preparedness supplies during the last full weekend of February of each year; and

WHEREAS, Act No. 2012-256 authorizes the county commission to provide for an exemption of county sales and use taxes for purchases of items covered by the Act during the same time period in which the state sales and use tax exemption is in place, provided a resolution to that effect is adopted at least fourteen days prior to 12:01 a.m. on the last Friday in February 25, 2022, and

WHEREAS, the Coosa County Commission has affirmatively voted to grant the exemption of county sales and use taxes on purchases covered by Act No. 2012-256 during the last weekend of February 2022, beginning at 12:01 a.m. on February, 25, 2022 and ending at twelve midnight on Sunday, February 27, 2022, the last weekend of February in 2022; and

WHEREAS, <u>Code of Alabama 1975</u>, § 11-51-210(e) requires that the county commission notify the Alabama Department of Revenue of any new local tax or amendment to an existing local tax levy at least 30 days prior to the effective date of the change; and

WHEREAS, the exemption of certain county sales and use taxes for the last full weekend of February, 2022 herein adopted by the county commission is an amendment to the county's sales and use tax levy warranting notice to the Alabama Department of Revenue as provided in *Code of Alabama 1975,§ 11-51-210(e)*;

WHEREFORE BE IT RESOLVED BY THE COOSA COUNTY COMMISSION that it does hereby provide for an exemption of the county sales and use tax on purchases of items covered by Act No. 2012-256 beginning at 12:01 a.m. on February 25, 2022 and ending at twelve midnight on Sunday, February 27, 2022.

BE IT FURTHER RESOLVED that a copy of this resolution be spread upon the minutes of the November 23, 2021 meeting of the Coosa County Commission, and be immediately forwarded to the Alabama Department of Revenue in compliance with <u>Code of Alabama 1975</u>;§ 11-51-210(e).

WHEREAS, County would benefit by voluntarily agreeing to extend its contracted annual participation in the Fund for a three-year period concluding on Soci. 30, 2024, at which time the provisions of the existing contract between County and the Fund will remain in force unless altered as provided therein.
NOW. THEREFORE, 8E IT RESOLVED by the County Commission that it renews its participation in the Fund through Sept. 30, 2024, and hereby directs its Chair to immediately provide the original signed copy of this resolution to the Fund.
AND, BE IT FURTHER RESOLVED, by the County Commission that, should it voluntarily withdraw from the Fund prior to Sept. 30, 2024, it agrees to return the 2024 Longevity Bonus provided by the Fund, plus five (5) percent annual interest.

Memorandum of Understanding

Between

Coosa County Commission

And the

Alabama State University Center for Leadership and Public Policy

THIS MEMORANDUM OF UNDERSTANDING, entered into on this 23 day of Number , 2021, by and between the Coosa County Commission, P.O. Box 10, Rockford, AL 35136 and Alabama State University Center for Leadership and Public Policy ("CLPP" or "Center"), Council Hall, Suite 318, Post Office Box 271, Montgomery, AL 36101-0271 (hereinafter collectively referred to as "the Parties").

In consideration of the mutual promises and covenants set forth herein, and other good and sufficient consideration, the parties agree to the following:

- 1. Deliverables Provided. The Center will provide the following services to the Coosa County Commission:
 - a. Creation and distribution of computer-generated district map(s) of current districts and the geographies making up fuese districts to enable Goosa County Commission to make changes to their districts
 - b. Distribution of domegraphic data by district and Census block to facilitate redistricting by Census block to meet the required 5% deviation in district size.
 - c. Creation and distribution of the resulting map and demographic data following redistricting.
 - d. Submission of final map and demographic data to the required State agencies and offices. Distribution of final maps and demographic data as requested by Coosa County Commission.
- Period of Agreement. This agreement will commence on November 23
 and end upon completion of the project.
- 3. Financial Arrangements. Upon acceptance of this contract, Coosa County Commission will provide a \$1,000.00 deposit for the services outlined in the agreement. Services will be billed against the deposit at the programming rate of \$50/hour, map cost by size and quantity, and travel costs (state mileage rate), not to exceed \$2,500.00. Should the final billed services not exceed the deposit, the remaining funds will be returned to Coosa County Commission. Any costs over the deposited amount will be billed upon completion of services.
- 4. Termination. This agreement may be terminated upon mutual agreement of the parties or upon 30 days written notice by one of the parties. The Center will cease performance of any work upon the receipt of notification of termination and all costs incurred by the Center prior to the issuance of that notice shall be paid by the Coosa County Commission.
- 5. Geverning Law. This agreement will be governed and construed in accordance with the laws of Page 1 of 2

the State of Alabama. In the event any legal action is brought by either party, such action shall be commenced in the State Court of Montgomery County, Alabama.

6. Entire Contract/Amendments. This contract states the entire agreement between the parties and merges herewith all statements, representation, and covenants heretofore made, and any other agreements not incorporated herein are void and of no effect. Any changes, modifications, or amendments to this contract must be reduced to and approved in writing by both parties.
