Coosa County Commission, AL regarding the 2020 Coosa County Commission Community Development Block Grant – COVID (CDBG-CV) Project Funding (Project Number CV-NC-20-033) requests a Formal Amendment for the above referenced project for the reallocation of funds. This request is necessary for the following reasons:

- The needs of Coosa County have changed since the initial funds of their CDBG-CV (Project Number CV-NC-20-033) were awarded.
- 2. The Coosa County Commission has determined that the Equality Food Banks for District 1 and District 4 have received adequate funding through various sources to supply the needs of citizens in the area.

## Project Revision Description
